1. ANNOUNCEMENT:

The South Coast MX Club, hereafter called the PROMOTER will conduct SCMX 2019 Club Race Series in the following categories:

The event shall take place at lot 4 3761 Old Princes Highway, Monarto, SA

2. JURISDICTION:

- 2.1. The abovementioned meeting has been authorised by Motorcycling SA Inc which has issued the Motorcycling Australia Permit Numbers C1950323, C19050326, C1950328 and is open to holders of current Motorcycling Australia Senior & Junior National Licences, Mini Licences (Demo only) and One Day Competition Licences.
- 2.2. The meeting will be held in accordance with the Manual of Motorcycle Sports (MOMS), current General Competition Rules (GCR's), these Supplementary Regulations, and any final instructions approved by Motorcycling SA Inc.

BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

3. ENTRIES:

- 3.1. Online entries will open 4 weeks before each round and close on the Friday before Race Day at 9pm, late entries close at 5pm on the Saturday before race day.
- 3.2. In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the South Coast MX Club, if such retention is approved by Motorcycling SA Inc.
- 3.3. Only entries received through Ridernet will be accepted.
- 3.4. THE RETURN OF ENTRY FEES FOR ANY RIDER WITHDRAWING FROM THE MEETING IS AT THE DISCRETION OF THE SOUTH COAST MX CLUB. PLEASE ALLOW 2 DAYS FOR FUNDS TO BE CLEARED

4. INSURANCE:

- 4.1. National Personal Accident Scheme provides basic cover for death and permanent disability.
- 4.2. Ambulance Insurance is compulsory for licensees.
- 4.3 IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE.

5. MEDICAL SERVICES:

First Care Medical will be in attendance from 8:00am until after the last event. EVERY COMPETITIOR MUST HAVE A CURRENT AMBULANCE INSURANCE COVER 6 ENTRY FEES:

- 7.2 Under 19's eligibility, A rider must be the holder of a Senior Race Licence, once a rider turns 19, they can no longer compete in the class, regardless of previous rounds completed.
- 7.3 All Juniors must have a current junior licence and must present their log books.

8. ENTRIES TO CONSTITUTE A CLASS:

- 8.1. To constitute a class, the number of contestants entered and competing in each class shall be six (6) per class.
- 8.2. Should there be insufficient entries in any class of competition, the decision to run or cancel the class, or to combine events and re-distribute any awards, will be at the discretion of the South Coast MX Club, subject to Motorcycling SA Inc. approval and the second class fee will be forfeited.

9. AWARDS AND PRIZE MONEY:

Rider points will be accumulated during the 3 races and totalled after the final race of the day. Each Class will be awarded 1st, 2nd and 3rd place ribbon. All non-competition participants will receive an award.

10 RACE FORMATS:

To be determined on the day subject to entries. Race order will be advised after sign-on is completed.

11. MACHINES AND RIDERS:

- 11.1 All machines entered must comply with the current GCRs for motocross competition and presented for scrutineering prior to competition commencing.
- 11.2 Multiple entry of the one machine in the same class of competition is Permitted.
- 11.3 "Change of Machine" form to be completed and approved by C.O.C via race secretary before start of next race.

12. GRID POSITIONS:

12.1 In all classes, gate selection will be via random peg selection.

13. RIDERS' BRIEFING:

A compulsory riders' briefing will be held prior to the commencement of racing, which ALL competitors MUST attend, failure to attend may result in a fine being issued to the competitor

For all competitors aged under 18, a parent/guardian must be in attendance with the competitor.

14. CAMERAS:

Competitors are referred to an updated rule regarding the use of camera as per the 2019 MOMs 10.13.2.1.

Cameras may be fitted to the motorcycle provided they are securely mounted. Camera mounts are subject to approval by the Chief Scrutineer. Helmet cameras are NOT permitted unless the camera is integrated into the helmet, by design of the manufacturer.

15. DRUG AND OR ALCOHOL TESTING:

- 15.1 All competitors and officials are advised that as part of the MA and MSA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Anti-Doping Authority and the Motorcycling SA Drug and Alcohol Policy.
- 15.2 If any doubts exist over banned substances it is recommended competitors contact the Drugs in Sport Hotline, tel 1800 020 506. When drug testing takes place, the payment of prizemoney may be delayed at the Motorcycling SA Inc. discretion until the results of the tests are known.
- 15.3 For the purposes of drug and alcohol testing, the commencement of the meeting will be deemed to be 6am with the completion of the meeting for the participant being when the participant has vacated the venue.

16. CODE OF CONDUCT:

All competitors, officials and parents are reminded of the Motorcycling Australia by-law - CODE OF CONDUCT (as stipulated in the GCRs), which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.

18. CIRCUIT DESCRIPTION:

- 18.1 Track consists of man-made jumps, drop-offs, banked curves, berms, straights, whoops and tabletops, approximately 1.65 kms.
- 18.2 All competitors will be given the opportunity to walk and inspect the track prior to any on track participation. The inspection must be done on foot.

19. STARTS:

19.1 GCRs 10.16.4.7 (a) 40 individual backward falling/self-penalizing gates will be used.

- 19.2 GCRs 10.16.4.9 (a) When the starter is ready, a 15 second sign will be held up for a full 15 seconds. At the end of 15 seconds, a 5 second sign will be displayed. The gate will drop between 5 and 10 seconds after the 5 second sign is shown.
- 19.2. GCRs 10.16.4.7 Preparation on the start gate is to be confined to the area between the rollback barrier and gate hinge (d) NO work is to be done in front of the start gate, unless advised be the starter.

20. PRACTICE:

All riders are required to commence and complete at least one full lap of practice – no practice, no ride. The Clerk of Course has discretion to permit into another race for riders unable to complete a lap, once commenced, due to mechanical reasons or an accident.

21. RACING:

- 21.1 Practice All classes 3 laps
- 21.2 3 Rounds of racing.
- 21.3 Racing Seniors 6 laps, Juniors 50-65 4 laps, 85-250 5 laps, Non-Comp 10 minutes.
- 21.4 Scoring points will be allocated as per GCRs for Motocross

22. NOISE: Changes implemented from 2013

- 22.1 Noise emission levels have been changed: with the 2m max method, the limit is 112 with a 4dB/A allowance
- 22.2 Competitors may be required to undergo a static noise test during the event.
- 22.3 No person may compete in any event on a machine whose emissions exceed the limits as noted in GCR
- 22.4. If a machine fails, it can be presented for re-testing several times.

23 LAND ACCESS

All land is private property and any access for riding anywhere other than the designated track is not permitted. Limited rubbish bins will be provided, so it is asked that all rubbish be taken off site when you leave. Because it is a privilege and **NOT** a right that we are allowed to use the track, we ask that everyone has the upmost respect for the track and the facilities. Each rider will be issued a rubbish bag at sign-on, you are expected to remove your rubbish with you when leaving the facility. Any rider failing to remove their rubbish will be issued \$50 fine

24 SPECIAL NOTES AND WARNINGS:

- 24.2 Dogs are **NOT PERMITTED ON THE PROPERTY** during racing, with exception of an Accredited Assistant Dog.
- 24.3 Alcohol and Smoking is **NOT PERMITTED** in the pit area.
- 23.4 Facilities: Toilet and showering facilities available onsite. Canteen facilities may be available.
- 24.6 STRICTLY NO NOISE AFTER 10PM SATURDAY NIGHT.
- 24.7 NO RIDINIG IN THE PITS UNLESS ADVISED ON THE DAY BY C.O.C
- 24.8 FAILURE TO ADHERE TO THESE RULES WILL RESULT IN A \$50 FINE PAYABLE TO THE CLUB
